TERMS AND CONDITIONS

ACCEPTANCE OF ORDER

THE CONTRACT FOR SALE OF GOODS IS CONCLUDED WHEN THE BUYER IS SIGNING AN ORDER
UNLESS THE SELLER REFUSES IT WITHIN THAT 30-DAY PERIOD.

CANCELLATION OF ORDER

THE ORDER CANNOT BE CANCELLED BY THE BYER ONCE RECIEVED BY THE SELLER.
THE SELLER CAN CANCEL THE ORDER FOR THE FOLLOWING REASONS: EG. THE BUYER ALREADY
OWES THE SELLER MONEY FOR PREVIOUS ORDERS, TECHNICAL REASONS, SHORTAGE OF RAW
MATERIAL OR OTHER "GENUINE" REASON.

PAYMENT

THE PAYMENT IS MADE, WITHIN 30 DAYS AFTER A CONCLUDED ORDER. THE PAYMENT IS MADE BY
BANK TRANSFER. THE ORDER WILL NOT BE PUT IN PRODUCTION UNTIL THE PAYMENT IS
RECIEVED. THE BUYER PAYS FOR TRANSPORTATION COSTS WHICH IS INVOICED SEPARATELY
AFTER THAT THE BUYER RECIEVED THE GOODS.

THE BUYER CANNOT SUSPEND PAYMENT OF MAKE A REDUCED PAYMENT ON THE BASIS OF ANY
FAULTS OF DEFICIENCIES IN THE GOODS.

RETENTION OF TITLE

OWNERSHIP OF THE GOODS DELIVERED WILL NOT PASS TO THE BUYER UNTIL THE GOODS HAVE
BEEN PAID FOR IN FULL.
IN THE CASE OF NON PAYMENT THE SELLER HAS THE RIGHT TO REPOSSESS THE GOODS FROM
THE BUYER, IF POSSIBLE RE-SELL THEM AND RECOVER FROM THE BYER ANY SHORTFALL
BETWEEN THE RESALE PRICE AND THE ORIGINAL INVOICE PRICE OF THE GOODS, OR THEIR FULL
INVOICE VALUE IF UNABLE TO RE-SELL THEM.

DELIVERY

THE GOODS WILL BE DELIVERED 120 DAYS AFTER CONCLUDED ORDER. THE SELLER HAS A
PERIOD OF GRACE OF 10 DAYS IN CASE OF DELAYED DELIVERY.
THE DELIVERY IS CONSTITUTED WHEN THE GOODS LEAVE SWEDEN.

TRANSPORT

THE GOODS TRAVEL AT THE RISK OF THE BUYER.

FAULTS

FAULTS SHOULD BE REPORTED TO THE SELLER IN WRITING WITHIN 8 DAYS, FROM THE DATE OF
DELIVERY IF THE DEFECTS ARE PATENT, OR, IF LATENT, FROM THE DATE OF DISCOVERY OF THE
FAULT. IN ANY EVENT, THE BUYER SHOULD INFORM THE SELLER WITHIN A MONTHS TIME.

RETURNS

RETURN OF GOODS MUST BE AUTHOURISED IN WRITING BY THE SELLER.

PLACE OF THE SALE

THE BUYER MUST SELL THE GOODS ORDERED ONLY IN THE PLACE SPECIFIED IN THE ORDER
UNLESS OTHERWISE AUTHORISED BY THE SELLER IN WRITING.

DISPUTES

THE CONDITIONS IN THIS CONTRACT IS UNDER THE TERMS OF THE SWEDISH LAW.
